1. Terms of Reference

The Contractor undertakes to perform the services/achieve the results listed in the Terms of Reference (Annex 1).

2. Contract Term and Assignment of Experts or the Consultant

The contract shall run from Beginning of November 2026 to 30.04.2027.

The Contractor shall deploy the experts listed in the price schedule (Annex 2) in accordance with Section 2.1 of the General terms and conditions of contract for supplying services and works on behalf of the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH in the version of 4 February 2026 ('Terms and Conditions 2025' below 'Terms and Conditions').

The expected periods of assignment and/or the period during which services are to be provided are set out in the Terms of Reference (Annex 1).

5.1 Fixed lump-sum remuneration of EUR (in words: EUR) shall be paid for the works to be performed by the Contractor.

5.2 Place of supply for VAT purposes

The Contractor provides services to the permanent establishment of GIZ Minerals for a Just Transition in Latin America and the Caribbean in Holanda 100, of. 604-605 Providencia, Santiago. In accordance with Section 3a, Paragraph 2, Sentence 2 of the German VAT Act (Umsatzsteuergesetz – UStG), the place of supply for VAT purposes is therefore in Chile.
