The request to participate consists of the following documents, which must be submitted in full, if applicable:

- Self-declaration of eligibility with attachments
- Declaration by candidate/bidding consortium (only to be submitted if applicable)
- Declaration - Eligibility through reliance upon the capacities of other entities (only to be submitted if applicable)

The following documents are not to be submitted at this stage, but only at the tender submission stage:

- Technical tender (including concepts and CVs)
- The form price schedule

Technical bids are weighted at 70%, price bids at 30%. Fixed budget items for price bids specified in the competition documents are not included in the evaluation and weighting of the same. The following formula is used for weighting:

$$= 0,7 \times \frac{\text{technical evaluation of the bidder}}{\text{Evaluation of the best technical bid}} + 0,3 \times \frac{\text{best offer}}{\text{bidder's price}}$$

GIZ reserves the right to change the contract by taking up an option pursuant to Section 132 (2) no 1 German Act Against Restraints on Competition (GWB) or entering into a follow-on contract pursuant to Section 14 (4) no 9 German Ordinance on the Award of Public Contracts (VgV) (see Section 7 of the terms of reference).

If we receive more than 5 requests to participate from eligible candidates, we will make a selection on the basis of the criteria laid out in the procurement documents and invite tenders only from the 5 candidates with the highest scores. We reserve the right to cancel the procurement procedure if we receive fewer than 3 requests to participate.

If it is not possible to make a clear selection of up to 5 candidates for the tendering phase on the basis of the criteria listed in the procurement documents (e.g. if a number of candidates achieve the same overall eligibility score), we reserve the right to increase the maximum number of 5.

We also reserve the right to award the contract on the basis of initial tenders without entering into negotiations.

We also reserve the right, once the initial tenders have been submitted, to make a selection on the basis of the criteria listed in the procurement documents and only to enter into negotiations with the 3 tenderers that receive the highest scores.

In addition, we reserve the right to conduct the negotiations in consecutive phases with a view to reducing the number of tenders under negotiation on the basis of the contract award criteria specified in the annex.
