Please note that this is a public invitation to tender so there will be no negotiations.

Please note that when you submit a tender, the tender is binding until the expiry of the deadline. The contract will come into force upon notification of its award within the deadline.

The tender documents, comprising the following, are to be submitted in their entirety:

- completed self-declaration and annexes (**incl. copy of certificate for commercial registration**)
- financial bid in the format provided (price schedule)
- technical bid: curriculum vitae (CV) for each expert and concept

When preparing the financial bid, you must adhere to the requirements of the specification of inputs as set out in the Terms of Reference. The tenders received will be subject to a technical assessment based on the CV and the concept in accordance with the annexed technical assessment grid. Only tenders that score at least 500 points in the technical assessment will be accepted for the financial evaluation. Technical bids that fail to reach this cut-off point will be regarded as unsuitable.

The technical bid is weighted at 70% and the financial bid at 30%.

Only If a consortium is to be formed for the service offered, please submit the consortial declaration.

Within the framework of the basic project described in the terms of reference, GIZ reserves the right to award contracts for additional services to the successful tenderer in this procedure.
